DECISION AND ORDER


By Order No. 19646, filed on September 30, 2002, the commission ordered VERIZON ADVANCED DATA, INC., fka BELL ATLANTIC NETWORK DATA, INC. (Respondent) to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 29, 2002 to show cause why Respondent's certificate of authority should not be suspended or revoked for failure to pay a public utility fee (Fee) that was due on July 31, 2001, pursuant to Hawaii Revised Statutes (HRS) § 269-30. On November 8, 2002, Respondent paid the Fee that was due on July 31, 2001.




