I.

By Decision and Order No. 19783, filed on November 19, 2002, the commission allowed VERIZON HAWAII INC.'s proposed tariff changes to take effect, upon the issuance of the decision and order. Thereafter, by Order No. 19842, filed on December 4, 2002, the commission granted Verizon Hawaii Inc.'s request to change the transmittal's effective date, from November 19, 2002 to February 1, 2003. This new effective date will allow Verizon Hawaii Inc., during January 2003, to notify its customers of the changes to the late payment and return payment charges.

By letter dated December 5, 2002, Verizon Hawaii Inc. transmitted its revised tariff sheets and customer notification message, in compliance with Order No. 19842. Accordingly, the commission will close the instant docket.




THE COMMISSION ORDERS that the instant docket is closed.
