I.

S. LONG TRUCKING SERVICES, LLC (Applicant) filed an application for a certificate of public convenience and necessity (CPCN) to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities and dump truck classifications. By Decision and Order No. 19301, filed on April 12, 2002, the commission granted Applicant a CPCN subject to certain requirements.

On December 16, 2002, Applicant filed a request to withdraw its application.¹ In light of this request, the commission finds good cause to void Decision and Order 19301, and to close this docket.


THE COMMISSION ORDERS:


1. Decision and Order No. 19301 is voided.


