DECISION AND ORDER

I.

By an application filed on November 19, 2002, TRANS MARINE, LLC (Applicant) requests a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification. The application is made pursuant to Hawaii Revised Statutes (HRS) § 271-12.




