ORDER

I.

By joint application filed on October 8, 2002, VERIZON HAWAII INC. and AMERITECH MOBILE COMMUNICATIONS, LLC (fka Ameritech Mobile Communications, Inc.), dba CINGULAR WIRELESS (collectively, Applicants) request approval of a negotiated interconnection agreement.

Copies of the application were served on the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy (Consumer Advocate).

By letter filed on December 16, 2002, Applicants advise the commission that the amendment to their interconnection agreement must be revised. 
THE COMMISSION ORDERS:


