ORDER

I.

By letter filed on April 2, 2002, DONALD POEPOE, SR., dba POI'S EXCAVATION (Petitioner), requested that certificate of public convenience and necessity no. 4067-C (Certificate No. 4067-C) be placed on inactive status. Certificate No. 4067-C authorizes Petitioner to transport property over irregular routes on the island of Maui in the general commodities (excluding break bulk and delivery service) and dump truck classifications.

On November 27, 2002, in Docket No. 02-0248, the commission issued Decision and Order No. 19821, which revoked Certificate No. 4067-C for Petitioner's failure to file his 2001 annual financial report in an appropriate form.


The revocation of Petitioner's operating authority renders moot Petitioner's request to place Certificate No. 4067-C on inactive status. Thus, we conclude that there is good cause to dismiss the petition in this docket.


II.


