ORDER

I.

By Decision and Order No. 16752, filed on December 14, 1998, the commission granted COOL WAVE TELECOMM SERVICES, INC. (Petitioner) a certificate of registration (COR) to operate as a pay telephone service provider in the State of Hawaii (State). Petitioner was issued COR 98-0362 by the commission.

By application filed on January 30, 2003, Petitioner requests commission approval to voluntarily surrender its COR. Petitioner states that presently, it "has no active payphone accounts." In follow-up thereto, Petitioner recently complied with the commission's directives to: (1) submit its annual financial reports; and (2) pay the applicable public utility fees.

The commission finds good cause to approve the proposed surrender of Petitioner's authority. In addition, because of Petitioner's status as a provider of pay telephone service, it has no customers *per se* to notify of its discontinuance of service. Thus, the customer notification requirement set forth in Hawaii Administrative Rules § 6-80-123 does not apply.

II.


THE COMMISSION ORDERS:


