ORDER

I.

By transmittal filed on March 12, 2003, KUWAYE TRUCKING, INC. seeks commission approval on short notice to increase its fuel surcharge, from 2.10 per cent to 2.79 per cent. Kuwaye Trucking, Inc.'s fuel supplier recently notified the property carrier of the following price increases in diesel fuel: (1) effective February 20, 2003, 2 cents per gallon; and (2) effective February 26, 2003, 9 cents per gallon.

Kuwaye Trucking, Inc. makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules (HAR) § 6-63-18. It proposes an effective date of March 15, 2003.

Upon review, the commission finds good cause to grant Kuwaye Trucking, Inc.'s request for approval on short notice. Kuwaye Trucking, Inc. shall promptly file its revised tariff sheet, incorporating the correct effective date.<sup>1</sup>

<sup>1</sup>In accordance with HAR § 6-63-18, Kuwaye Trucking, Inc.'s short notice filing is subject to a minimum three business day waiting period. Hence, the effective date of its tariff change is March 18, 2003, no earlier.

II.


THE COMMISSION ORDERS:


1. Kuwaye Trucking, Inc.'s transmittal, filed on March 12, 2003, is approved on short notice, to be effective from March 18, 2003.


2. Kuwaye Trucking, Inc. shall promptly file its revised tariff sheet, consistent with the terms of this order.


