ORDER

I.

ISLAND RV, INC. holds a certificate of public convenience and necessity to operate as a motor carrier in the 1-to-7 and 8-to-25 passenger classifications over irregular routes, on the island of Hawaii (excluding Waipio Valley). In accordance with its commission-approved tariff, Island RV, Inc. presently offers certain passenger services, including:

1. An on-call, unscheduled pick-up service between certain Kailua-Kona hotels, Kohala Coast hotels, and the Kona International Airport, or vice versa. (See page 1 of Island RV, Inc.'s transmittal.)
2. Its 25-passenger mini bus charter service, at \$85 per hour. (See page 1 of Island RV, Inc.'s transmittal.)

By transmittal filed on April 28, 2003, Island RV, Inc. seeks commission approval on short notice to:

1. Establish its new "Island RV Airport - Hotel Shuttle" service for passengers traveling between certain Kailua-Kona hotels and the Kona International Airport, or vice versa. (See page 5 of Island RV, Inc.'s transmittal.)

This shuttle service will apply to pre-booked, scheduled pick-ups from designated Kailua-Kona hotels. Island RV, Inc.'s transmittal lists the

proposed per passenger rate, ranging from \$8 to \$14, on a one-way basis.

2. Increase its 25-passenger mini bus charter rate from \$85 to \$90 per hour.

Island RV, Inc. makes its request in accordance with Hawaii Revised Statutes § 271-21 and Hawaii Administrative Rules (HAR) § 6-63-18. It proposes an effective date of May 1, 2003.

In support of its request, Island RV, Inc. states:

1. The new "Island RV Airport - Hotel Shuttle" service is in response to the hotels' demand, and is projected to increase the carrier's passenger load and revenues.
2. The \$5 increase for the 25-passenger mini bus charter rate is intended to offset the higher cost of fuel.

Upon review, the commission finds good cause to grant Island RV, Inc.'s request for approval on short notice. Island RV, Inc. shall promptly file its revised tariff sheets, incorporating the correct effective date of May 2, 2003.¹

II.


THE COMMISSION ORDERS:

1. Island RV, Inc.'s transmittal, filed on April 28, 2003, is approved on short notice, to be effective from May 2, 2003.
2. Island RV, Inc. shall promptly file its revised tariff sheets, consistent with the terms of this order.

¹In accordance with HAR § 6-63-18, Island RV, Inc.'s short notice filing is subject to a minimum three business day waiting period. Hence, the effective date of its tariff changes is May 2, 2003, no earlier.
