I.

On April 17, 2003, the commission issued its monthly order governing tariffs filed by public utilities -- Order No. 20128. Upon further review, the commission, on its own motion, will amend Order No. 20128 by removing from page 2, the transmittal filed on April 7, 2003, by Buyers United, Inc., dba buyersonline, dba United Carrier Networks.¹

II.



¹Buyers United, Inc.'s application for a certificate of authority, filed on March 6, 2003, in Docket No. 03-0056, is currently pending before the commission. On March 24, 2003, the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy (Consumer Advocate), filed its position statement, recommending certain revisions to Buyers United, Inc.'s proposed tariff. Accordingly, on April 7, 2003, Buyers United, Inc. submitted its updated, proposed tariff, incorporating the Consumer Advocate's revisions.


In Order No. 20128, the commission prematurely treated Buyers United, Inc.'s April 7th submission as an initial tariff filed by a certificated telecommunications carrier.
