I.

By Order No. 20127, filed on April 17, 2003, the commission suspended AT&T Communications of Hawaii, Inc.'s transmittal number 03-10, which proposed certain revisions to section 2.5.3 of its tariff, governing billing disputes. In addition, the commission instructed AT&T Communications of Hawaii, Inc. to: (1) withdraw its proposed revisions to section 2.5.3; or (2) explain in writing "why it believes such provision should not be withdrawn."

By letter dated May 6, 2003, filed on May 7, 2003, AT&T Communications of Hawaii, Inc. responded to Order No. 20127 by withdrawing, without prejudice, its transmittal number 03-10.


Having complied with Order No. 20127, the commission will close the instant docket.

II.


THE COMMISSION ORDERS that the instant docket is closed.


