ORDER

I.

Pursuant to Decision and Order No. 20342, filed on July 18, 2003 in this docket ("Decision and Order"), MOLOKAI PUBLIC UTILITIES, INC. ("MPUI"), was ordered, among other things, to make certain changes to its rate schedule. On July 21, 2003, MPUI filed its revised rate schedule with the commission, reflecting the revisions ordered by the Decision and Order.

Upon a review of MPUI's revised rate schedule, we find that MPUI has made the appropriate tariff revisions, as ordered by the commission, and that the rate schedule should be approved. Accordingly, we conclude that MPUI has satisfied the conditions relating to its tariff as set forth in the Decision and Order, that its tariff should be approved, and that MPUI's rate increase should take effect as of the date of this order.

II.


THE COMMISSION ORDERS:


1. MPUI's revised tariff sheet and rate schedule are approved.
