ORDER

We approved the application of LIONEL LAWRENCE GOMES, dba L & L TRUCKING ("Applicant"), for a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Hawaii in the dump truck classification by issuing Decision and Order No. 20148, filed on April 23, 2003. We voided Decision and Order No. 20148 by issuing Order No. 20455, filed on September 19, 2003, because we found that Applicant did not comply with the requirements of Decision and Order No. 20148.


Upon further review of the record in this matter, the commission finds that Order No. 20455 was issued in error. The Applicant has complied with the requirements set forth under Decision and Order No. 20148 and a certificate of public convenience and necessity was issued to Applicant on May 8, 2003. The commission finds good cause to void Order No. 20455 because Applicant complied with Decision and Order No. 20148. The commission also finds good cause to reinstate Decision and Order No. 20148.


THE COMMISSION ORDERS:


1. Order No. 20455 is voided.




