DECISION AND ORDER

The commission ordered JOSEPH K. ALANA JR., dba ALANA EQUIPMENT RENTAL ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of public convenience and necessity number 2124-C should not be suspended or revoked for failure to file an annual financial report ("AFR"), pursuant to Hawaii Revised Statutes ("HRS") § 271-25 and Hawaii Administrative Rules ("HAR") § 6-62-42(a), and to pay an annual motor carrier gross revenue fee ("Fee"), pursuant to HRS § 271-36 and HAR § 6-62-24(a), for the year 2002.


On November 7, 2003, Respondent filed its 2002 AFR and paid its Fee and \$579.59 of penalties and interest that the commission assessed, pursuant to HRS § 271-27(i) and HAR §§ 6-62-24(b), 6-62-24(c), and 6-62-42(d).


The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 20480, filed on October 27, 2003, should be vacated.


THE COMMISSION ORDERS that Order No. 20480 is vacated and this docket is closed.


