I.

Introduction

On November 3, 2003, OLOWALU WATER COMPANY, LLC ("Applicant") submitted its updated tariff, which incorporates the amended tariff sheets and rate schedules, requested by the commission in Decision and Order No. 20611 ("Decision and Order No. 20611"), filed on October 30, 2003, in this docket.
