ORDER

I.

Request to Extend Inactive Status

On November 28, 2003, CARAVAN ISLAND TOURS OF HAWAII, INC. ("Petitioner") filed a letter requesting that the inactive status of its certificate of public convenience and necessity no. 861-C ("Certificate No. 861-C") be extended for an additional year. By Order No. 19771, filed on November 13, 2002, in this docket, Certificate No. 861-C was placed on inactive status until November 13, 2003.

The commission notes that pursuant to Hawaii Revised Statutes § 271-19, the commission may grant inactive status for a cumulative period not to exceed two years over the life of the certificate. Petitioner has 202 days remaining of this cumulative two-year period.¹ Accordingly, we find that there is good cause to

By Order No. 16637, filed on October 28, 1998, Certificate No. 861-C was reinstated to active status pursuant to Petitioner's request, thus leaving one year and 202 days available

extend Petitioner's inactive status for this additional 202-day period.

II.

Orders

THE COMMISSION ORDERS:

1. Petitioner's Certificate No. 861-C is placed on inactive status for an additional 202-day period, until June 2, 2004.

2. If Certificate No. 861-C is not reactivated prior to the expiration of the period of inactivity, it shall be declared abandoned and revoked. Petitioner may reactivate the certificate at any time prior to the expiration of the inactive period by filing a request to reactivate with the commission, and fulfilling the requirements for motor carriers including, but not limited to, filing of appropriate insurance documents and publication of a lawful tariff.


3. Petitioner shall not transfer its inactive certificate unless Petitioner can first establish good cause to the commission for the transfer, and the commission has approved the request to transfer.


to Petitioner if it desired to place Certificate No. 861-C on inactive status for a cumulative period of two years. By Order No. 19771, filed on November 13, 2002, Certificate No. 861-C was placed on inactive status for an additional year, thus leaving 202 days available for inactive status.






