I.

Request to Withdraw Application

On January 9, 2004, COMMUNICATIONS NETWORK BILLING, INC. ("Applicant") filed an application requesting a certificate of authority to provide intrastate telecommunications services within the State of Hawaii on a resold basis. Applicant makes its request pursuant to Hawaii Revised Statutes §§ 269-7.5 and 269-16, and Hawaii Administrative Rules § 6-80-17.

On March 1, 2004, Applicant requests that the commission withdraw the application, filed on January 9, 2004.


