ORDER

NPCR, INC., dba NEXTEL PARTNERS ("Nextel Partners"), requests the commission's designation as an eligible telecommunications carrier for the service area of the State of Hawaii.<sup>1</sup> Nextel Partners makes its request in accordance with: (1) sections 254(e) and 214(e) of the federal Telecommunications Act of 1996; and (2) Hawaii Administrative Rules § 6-81-9(a). Nextel Partners requests the designation as a prerequisite to receiving federal universal service support.

Nextel Partners served copies of the application upon the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate"). The Consumer Advocate, it appears, has concluded its investigation of Nextel Partners' application.<sup>2</sup>

THE COMMISSION ORDERS the Consumer Advocate to file its position statement by June 1, 2004.


