ORDER


<sup>1</sup>On February 6, 2004, the Hawaii Supreme Court issued its Summary Disposition Order: (1) remanding E Noa Corporation's complaint to the commission; and (2) instructing the commission to hold a hearing on the complaint. In lieu of a hearing, E Noa Corporation withdraws its complaint, with prejudice, in the "interests of administrative efficiency in furtherance of its role as a responsible member of the motor carrier community." 
