

STIPULATED PROCEDURAL ORDER

On or about December 3, 2003, Hawaiian Electric Company, Inc. ("HECO") and the Division of Consumer Advocacy of the Department of Commerce and Consumer Affairs ("Consumer Advocate"), (collectively, the "Parties"), submitted a Stipulated Procedural Order to the Commission for this docket. On December 15, 2003, the Commission issued Stipulated Procedural Order No. 20714 ("SPO No. 20714") which established, among other things, the schedule of proceedings for this docket.

On February 10, 2004, the Consumer Advocate requested a modification of the procedural schedule for the remainder of the proceeding, as follows:

CA Statement of Position ("SOP")	March 19, 2004
HECO SOP, if necessary*	April 5, 2004

* If the CA objects to approval of the application, or requests that approval be subject to conditions.

On February 19, 2004, the Commission issued Order No. 20806 approving the Consumer Advocate's request and amended the schedule of proceedings for this docket.

On March 19, 2004, the parties submitted a stipulated procedural order that amended the schedule as follows:

* If the CA objects to approval of the application, or requests that approval be subject to conditions.

On February March 24, 2004, the Commission issued Order No. 20863 approving the amended schedule of proceedings for this docket.

HECO plans to submit a response to the CA’s SOP, and requires further time to complete its SOP. HECO requests an extension, to May 10, 2004, to submit its SOP. The CA does not object to this request.

Hawaii Administrative Rules § 6-61-23(a)(1) provides the Commission with discretion, for good cause shown, to enlarge a period by which a required act must be completed, if a written request is made before the expiration of the period originally prescribed. The Commission finds good cause in this instance to enlarge the deadline from April 19, 2004 to May 10, 2004 for HECO's SOP to comply with the Commission's order and the request is granted and so ordered.


