ORDER

ENHANCED COMMUNICATIONS NETWORK, INC. ("Petitioner") holds a certificate of authority ("COA") to operate as a reseller of intrastate telecommunications services.¹ The commission issued COA 02-0043 to Petitioner.

Petitioner requests the commission's approval to voluntarily surrender its COA.² Petitioner submitted its applicable annual financial reports and public utility fees, in response to the commission's directive.

The commission approves: (1) the voluntary surrender of Petitioner's COA; and (2) waives the customer notification requirement set forth in Hawaii Administrative Rules ("HAR") § 6-80-123(a).³

³Petitioner's annual financial reports reveal that it has not provided telecommunications services in the State of Hawaii, and thus, has no Hawaii-based customers to notify of its discontinuance of telecommunications services.

THE COMMISSION ORDERS:

1. Petitioner's request to surrender COA 02-0043 to operate as a reseller of intrastate telecommunications services is approved, effective from the date of this order. Petitioner shall promptly return COA 02-0043 to the commission.

2. The customer notification requirement set forth in HAR § 6-80-123(a) is waived.


