ORDER AMENDING PREHEARING ORDER NO. 20922

I.

Introduction

On April 2, 2004, THE DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS, KAUAI ISLAND UTILITY COOPERATIVE, HAWAIIAN ELECTRIC COMPANY, INC., HAWAII ELECTRIC LIGHT COMPANY, INC., MAUI ELECTRIC COMPANY, INC., HESS MICROGEN, THE GAS COMPANY, PACIFIC MACHINERY, INC., JOHNSON CONTROLS, INC., HAWAII RENEWABLE ENERGY ALLIANCE, LIFE OF THE LAND, THE COUNTY OF MAUI, THE COUNTY OF KAUAI AND THE DEPARTMENT OF BUSINESS ECONOMIC DEVELOPMENT AND TOURISM (collectively referred to as "Parties and Participants") filed their Proposed Stipulated Prehearing Order for commission review and approval, pursuant to Order No. 20834, filed on March 3, 2004. On April 23, 2004, the commission issued Prehearing Order No. 20922 approving and adopting, in part, and modifying, in part, the Parties' and Participants' Proposed Stipulated Prehearing Order attached as Exhibit 1.

Upon further review, the commission finds and concludes that Prehearing Order No. 20922 should be amended as follows:

Section VII, entitled "COPIES OF TESTIMONIES, EXHIBITS, AND INFORMATION REQUESTS," of the Parties' and Participants' Proposed Stipulated Prehearing Order (Exhibit 1) attached to Prehearing Order No. 20922 is amended by requiring the Parties and Participants file the Original plus ten (10) copies of documents filed with the commission instead of Original plus eight (8) copies. Moreover, because the commission intends to post copies of all filings in this docket on the commission's internet website, the commission will require the Parties and Participants to provide an electronic copy of all past and future filings with the commission. As soon as practicable, the Parties and Participants are thus instructed to provide electronic copies of all filings previously filed with the commission in this docket.

Orders




