DECISION AND ORDER

The commission ordered KARIM CHERKI, dba KC GOLD LIMOUSINE ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of public convenience and necessity ("CPCN") number ("No.") 1635-C should not be suspended or revoked for failure to file an annual financial report, pursuant to Hawaii Revised Statutes ("HRS") § 271-25 and Hawaii Administrative Rules ("HAR") § 6-62-42(a), and pay an annual motor carrier gross revenue fee, pursuant to HRS § 271-36 and HAR § 6-62-24(a), for 2002.¹

On January 16, 2004, Respondent filed his 2002 AFR and paid his Fee. Respondent paid \$822.71 in penalties and interest assessed by the commission, pursuant to HRS § 271-27(i) and HAR

§§ 6-62-24(b), 6-62-24(c), and 6-62-42(d), for Respondent's untimely AFR filing and annual Fee payment, in two installments: \$92.50 on January 16, 2004 and \$730.21 on January 20, 2004.


The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 20501, filed on October 27, 2003, should be vacated.

THE COMMISSION ORDERS that Order No. 20501 is vacated and this docket is closed.


