DECISION AND ORDER

The commission ordered HN KOBAYASHI CORPORATION, dba BIG GOLF TOURS ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of public convenience and necessity number ("No.") 1549-C should not be suspended or revoked for failure to file its 2002 annual financial report ("AFR"), pursuant to Hawaii Revised Statutes ("HRS") § 271-25 and Hawaii Administrative Rules ("HAR") § 6-62-42(a), and to pay its 2002 annual motor carrier gross revenue fee ("Fee"), pursuant to HRS § 271-36 and HAR § 6-62-24(a).<sup>1</sup>

On November 19, 2003, Respondent filed its 2002 AFR and on November 20, 2003, paid its Fee and \$949.06 in penalties and

interest that the commission assessed pursuant to HRS § 271-27(i) and HAR §§ 6-62-24(b), 6-62-24(c), and 6-62-42(d).




THE COMMISSION ORDERS that Order No. 20508 is vacated and this docket is closed.


