DECISION AND ORDER

The commission ordered TELEPHONE COMPANY OF CENTRAL FLORIDA, INC. ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 26, 2003 to show cause why Respondent's certificate of authority should not be suspended or revoked for failure to pay a public utility fee ("Fee") on December 31, 2002, pursuant to Hawaii Revised Statutes § 269-30. On November 19, 2003, Respondent paid the Fee that was due on December 31, 2002.

The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable laws, rules, and regulations, and concludes that Order No. 20549, filed on October 27, 2003, should be vacated.

THE COMMISSION ORDERS that Order No. 20549 is vacated
and this docket is closed.


