ORDER

NEXTEL WEST CORP. ("Petitioner") holds a certificate of registration ("COR") to provide commercial mobile radio services ("CMRS") in the State of Hawaii (the "State").<sup>1</sup> On October 4, 1996, the commission issued COR-0001 to Petitioner.

Petitioner requests the commission's approval to voluntarily surrender its COR-0001, by a "Surrender of Certificate of Registration," filed on March 5, 2004. Petitioner explains that:

1. In 1999, Petitioner transferred its assets and customer base to NPCR, Inc., as authorized by Decision and Order No. 17036, filed on June 15, 1999, in Docket No. 99-0038, *In re NPCR, Inc.* The commission issued NPCR, Inc. a COR to provide CMRS in the State. NPCR, Inc., aka Nextel Partners, currently provides CMRS to its Hawaii-based customers.

2. Petitioner has no Hawaii-based customers and "currently does not offer CMRS services in Hawaii."

On August 30, 2004, Petitioner paid its outstanding public utility fees, in response to the commission's directive.

The commission: (1) approves the voluntary surrender of Petitioner's COR; and (2) waives the customer notification requirement set forth in Hawaii Administrative Rules ("HAR") § 6-80-123(c), as Petitioner represents that it does not have any Hawaii-based customers to notify of its discontinuance of CMRS.<sup>2</sup>

THE COMMISSION ORDERS:

1. Petitioner's request to surrender COR-0001 is approved, effective from the date of this order. Petitioner shall promptly return COR-0001 to the commission.

2. The customer notification requirement set forth in HAR § 6-80-123(c) is waived.

3. This docket is closed.


