DECISION AND ORDER

The commission issued Order No. 21286 on September 7, 2004 ordering INTERSTATE TELECOMMUNICATIONS, INC. ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 6, 2004 to show cause why Respondent's certificate of registration should not be suspended or revoked for its failure to pay the public utility fee ("Fee") that was due on December 31, 2003, pursuant to Hawaii Revised Statutes § 269-30.


Subsequent to the issuance of Order No. 21286, Respondent paid the Fee that was due on December 31, 2003.


The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable laws, rules, and regulations, and concludes that Order No. 21286, filed on September 7, 2004, should be vacated, and that this docket should be closed.

THE COMMISSION ORDERS that Order No. 21286 is vacated
and this docket is closed.


