ORDER

I.

Introduction

On August 27, 1997, the commission granted PACIFIC LIGHTNET, INC.'S (fka, GST TELECOM HAWAII, INC. and hereinafter referred to as "PLNI") request that the commission open a generic docket to address issues relating to the establishment of the minimum point of entry ("MPOE") as the demarcation point and regulation of the installation and maintenance of inside wiring.¹

¹Order No. 15843, filed on August 22, 1997. Order No. 15843 also made, PLNI, VERIZON HAWAII, INC. (fka, GTE HAWAIIAN TELEPHONE COMPANY INCORPORATED), and the DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS parties to the proceeding. The BUILDING OWNERS & MANAGERS ASSOCIATION - HAWAII, INC., the HAWAII COUNCIL OF ASSOCIATION OF APARTMENT OWNERS, AT&T COMMUNICATIONS OF HAWAII, INC., TIME WARNER COMMUNICATIONS OF HAWAII, L.P. dba OCEANIC COMMUNICATIONS, the UNITED STATES DEPARTMENT OF DEFENSE, SPRINT COMMUNICATIONS COMPANY, L.P., and the HAWAII HOTEL ASSOCIATION were subsequently allowed to be parties as intervenors (collectively, all parties and intervenors noted above referred to as "Parties"). Order No. 15940, filed on September 23, 1997, Order No. 16093,

The Parties' initial and rebuttal position statements were filed in September 1998 and October 1998, respectively, addressing the issues of this proceeding.

II.

Discussion

The commission finds it necessary and beneficial to provide the Parties in this proceeding an opportunity to review and update their positions and the status of the matters in this docket before we proceed in addressing the issues established in this docket. Thus, we conclude that within sixty (60) days from the date of this order, the Parties should update the record by filing with the commission either: (1) a supplemental or amended position statement; or (2) a brief status report stating, among other things, whether their position has changed since their submissions to the commission in 1998. Further commission action to address the outstanding issues in this docket will follow.

III.

Order


THE COMMISSION ORDERS the Parties to review and update the information and data contained in the docket, and within sixty (60) days from the date of this order, the Parties shall update the record by filing with the commission either: (1) a supplemental or amended position statement; or (2) a brief


status report stating, among other things, whether their position has changed since their submissions to the commission in 1998. Further commission action to address the outstanding issues in this docket will follow.
