ORDER

TELEPHONE COMPANY OF CENTRAL FLORIDA, INC.
("Petitioner") holds a certificate of authority ("COA") to operate as a reseller of intrastate telecommunication services.¹ Petitioner, on January 30, 1998, was issued COA-0111 by the commission.

Petitioner requests the commission's approval to voluntarily surrender its COA.² Petitioner, as part of its request, submitted its 2002 annual financial report ("AFR") and a portion of its outstanding public utility fee. To date, Petitioner has not submitted its 2003 and 2004 AFRs or its public utility fee based on its 2004 revenues.

Given its non-provision of telecommunications services in the State of Hawaii, the commission: (1) approves the voluntary surrender of Petitioner's COA-0111; and (2) waives

the customer notification requirement set forth in Hawaii Administrative Rules ("HAR") § 6-80-123(a).³

THE COMMISSION ORDERS:

1. Petitioner's request to surrender COA-0111 to operate as a reseller of intrastate telecommunication services is approved, effective from the date of this order. Petitioner shall promptly return COA-0111 to the commission.

2. The customer notification requirement set forth in HAR § 6-80-123(a) is waived.

3. This docket is closed.


