ORDER

I.

On August 2, 2004, STROLL PATROL TOURS, LLC ("Applicant") filed an application requesting temporary authority to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification. The application is made pursuant to Hawaii Revised Statutes § 271-16. By Decision and Order No. 21435, filed on November 1, 2004, in Docket No. 04-0193, we granted Applicant's request for permanent authority to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification. Having granted such authority on a permanent basis, we have rendered moot the instant application for the same authority on a temporary basis. We, thus, conclude that there is good cause to dismiss the application herein.

THE COMMISSION ORDERS:


1. The application in this docket, having been rendered moot, is dismissed.


