ORDER

The commission instructs the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate"), to file a response to HAWAII WATER SERVICE COMPANY, INC.'s ("HWSCI") Motion for Partial Reconsideration ("Motion").

On February 22, 2005, HWSCI filed its Motion: (1) seeking the partial reconsideration of Decision and Order No. 21644, filed on February 11, 2005; and (2) pursuant to Hawaii Administrative Rules ("HAR") §§ 6-61-41 and 6-61-137. HWSCI's Motion is supported by the Affidavit of its General Manager. HWSCI does not request a hearing on its Motion.


HWSCI served copies of its Motion upon the Consumer Advocate. HAR § 6-61-141 provides that "[t]he commission may allow replies to a motion for rehearing or reconsideration or a stay, if it deems those replies desirable or necessary." The commission instructs the Consumer Advocate, as a statutory party to this proceeding,¹ to file a response to HWSCI's Motion, by March 4, 2005.




THE COMMISSION ORDERS that the Consumer Advocate:
