ORDER

In response to the compliance filing by THE GAS COMPANY, LLC ("TGC") on February 11, 2005, the commission closes this docket.

On February 8, 2005, the commission allowed TGC's Transmittal No. 05-01 to take effect on February 14, 2005: (1) as modified to include the additional language mutually agreed upon by TGC and the Division of Consumer Advocacy; and (2) subject to TGC's filing of its revised tariff sheets that incorporate the agreed upon additional language.<sup>1</sup> On February 11, 2005, TGC filed its revised tariff sheets, in compliance with Order No. 21643.<sup>2</sup>

THE COMMISSION ORDERS that this docket is closed.
