ORDER


On November 9, 2004, ABDER S. "TONY" ABURABI ("Petitioner") filed a request to place his certificate of public convenience and necessity no. 1324-C ("Certificate No. 1324-C") on inactive status. On March 30, 2005, Applicant filed a request to reactivate Certificate No. 1324-C.

The commission has not yet ordered that Certificate No. 1324-C be place on inactive status, thus, the commission will treat Petitioner's request of March 30, 2005 to reactivate Certificate No. 1324-C as a request to withdraw the petition filed on November 9, 2004.
