ORDER

By this Order, the commission orders that the application filed by AUSAGE EMOSI ("Applicant") on October 22, 2004, is dismissed without prejudice and this docket is closed.

I.

Application for Common Carrier Authority

On October 22, 2004, Applicant filed an application requesting a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification.

By a notice of dismissal dated March 18, 2005, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of his application must be submitted in writing and filed not later that

ten (10) days from the date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.

II.

Findings and Conclusions

Applicant did not file an objection to the dismissal of his application. We, thus, find that there is good cause to dismiss the application in this docket.

III.

Orders

THE COMMISSION ORDERS that the application filed by Applicant on October 22, 2004, is dismissed without prejudice and this docket is closed.


