By this Order, the commission orders that certificate of public convenience and necessity no. 5138-C ("Certificate No. 5138-C"), held by G & E, INC. ("Petitioner"), is revoked and this docket is closed.

Request to Place Common Carrier Authority on Inactive Status

By Order No. 21017, filed on May 28, 2004, Certificate No. 5138-C, held by Petitioner, was placed on inactive status until May 28, 2005.

Order No. 21017 informed Petitioner that if Certificate No. 5138-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to May 28, 2005, the commission would deem it to be abandoned and revoked.

Orders


THE COMMISSION ORDERS that Certificate No. 5138-C is revoked, and this docket is closed unless otherwise ordered by the commission.


