ORDER

The commission finds that the revised tariff sheets and rate schedules filed by WAIKOLOA WATER COMPANY, INC., dba WEST HAWAII WATER COMPANY ("Waikoloa Water"), on July 15, 2005, comply with Decision and Order No. 21919, filed on July 15, 2005.<sup>1</sup>

On July 15, 2005, Waikoloa Water timely filed its revised tariff sheets and rate schedules, as part of the commission's approval of its request for a general rate increase. The commission acknowledges the receipt of Waikoloa Water's filing, which complies with Decision and Order No. 21919.

<sup>1</sup>The commission, by Decision and Order No. 21919, adopted its Proposed Decision and Order No. 21885, filed on June 22, 2005, as its Decision and Order in this proceeding. An Ordering Paragraph of the Proposed Decision and Order and follow-up Decision and Order, respectively, instructed Waikoloa Water to file its revised tariff sheets and rate schedules for the commission's review and approval.

THE COMMISSION ORDERS:


1. Waikoloa Water's revisions to its tariff rules, as set forth in its July 15, 2005 filing, shall take effect from the date of this Order.


2. Waikoloa Water's revised rate schedules, as set forth in its July 15, 2005 filing, shall take effect from August 1, 2005.
