ORDER

By this Order, the commission orders that certificate of public convenience and necessity no. 1681-C ("Certificate No. 1681-C"), held by HITS HAWAII, INC., dba HOLIDAY INTERNATIONAL TRAVEL SERVICE ("Petitioner"), is revoked and this docket is closed.

I.

Request to Place Common Carrier Authority on Inactive Status

By Order No. 21092, filed on June 29, 2004, Certificate No. 1681-C, held by Petitioner, was placed on inactive status until June 29, 2005.

Order No. 21092 informed Petitioner that if Certificate No. 1681-C was not reactivated prior to the expiration of the period of inactivity, i.e., prior to June 29, 2005, the commission would deem it to be abandoned and revoked.

Findings and Conclusions

Certificate No. 1681-C was not reactivated prior to June 29, 2005. Accordingly, we find that there is good cause to revoke Certificate No. 1681-C.


