# **ORDER**

By this Order, the commission finds that the revised tariff and rate schedules of HOH UTILITIES, LLC ("HOH"), filed on February 28, 2006, and further revised and filed on March 13, 2006, comply with Decision and Order No. 22286, filed on February 16, 2006 in this docket, and shall take effect from the date of this Order.

# Tariff Sheets and Rate Schedules

On February 16, 2006, the commission issued Decision and Order No. 22286 in which it approved HOH's request for a general rate increase of \$95,678, or approximately 23.3% over revenues at present rates, for the 2005 calendar test year, and ordered HOH to file revised tariff sheets and rate schedules with the commission "within ten (10) days of the issuance of this Decision and Order. The rate increase shall take effect upon the commission's review and approval of this filing." <sup>1</sup>

On February 28, 2006, HOH timely filed its revised tariff sheets and rate schedules, as part of the commission's approval of its request for a general rate increase. On March 13, 2006, HOH supplemented its revised tariff sheets and rate schedules with futher revised sheets in which it corrected certain inadvertent errors.

Having reviewed HOH's revised tariff sheets and rate schedules, including Second Revised Sheet 24, the commission finds that they comply with Decision and Order No. 22286.

#### THE COMMISSION ORDERS:

- 1. HOH's revised tariff sheets and rate schedules, filed on February 28, 2006, as supplemented by further revisions filed on March 13, 2006, shall take effect from the date of this Order.
