ORDER

By this Order, the commission finds that HAWAII-AMERICAN WATER COMPANY's ("HAWC") tariff, filed on March 31, 2006, complies with Decision and Order No. 22299, filed on February 28, 2006, and is allowed to take effect from March 31, 2006, the closing date of the subject transaction approved by the commission in Decision and Order No. 22299.

I.

HAWC's Tariff

On February 28, 2006, the commission issued Decision and Order No. 22299, approving the sale and transfer of MAUNA LANI STP, INC.'s ("Mauna Lani STP") utility assets, operations, and certificate of public convenience and necessity to HAWC, subject to certain conditions.¹ Decision and Order No. 22299, Ordering Paragraph No. 1(G), mandated:

¹The Parties in this proceeding are HAWC, Mauna Lani STP, and the Department of Commerce and Consumer Affairs, Division of Consumer Advocacy ("Consumer Advocate").

Promptly after closing of the subject transaction, HAWC shall file with the commission and also serve on the Consumer Advocate its tariff for the Mauna Lani service area, to reflect the change in the entity providing wastewater utility service to the customers in said service area. HAWC's tariff shall include its replacement service area map.

Decision and Order No. 22299, Ordering Paragraph No. 1(G), at 36 (emphasis added).

By letter dated March 31, 2006, HAWC: (1) informed the commission that the subject transaction closed as scheduled on March 31, 2006; and (2) transmitted its tariff for the Mauna Lani service area, with an effective date of March 31, 2006, to correspond with the date of closing.²

Having reviewed HAWC's tariff, the commission finds that it complies with Decision and Order No. 22299.

²HAWC enclosed: (1) a "clean" version of its tariff, reflecting the change in name to HAWC and including its replacement service area map; and (2) a black-line version that includes the notations "reflecting the changes made to Mauna Lani STP's previously-filed tariff[.]" HAWC's letter, dated March 31, 2006, at 1.

Order

THE COMMISSION ORDERS:




