STIPULATED PROCEDURAL ORDER


By Order No. 22300 filed February 28, 2006 in Docket No. 05-0288

(Consolidated), the Public Utilities Commission (the "Commission") instructed Applicants Waikoloa Resort Utilities, Inc. d/b/a West Hawaii Utility Company ("WHUC") and Waikoloa Water Company, Inc. d/b/a West Hawaii Water Company's ("WHWC"), the Division of Consumer Advocacy of the Department of Commerce and Consumer Affairs ("CA"), and Intervenor Waikoloa Mauka, LLC ("Waikoloa Mauka") to submit a stipulated procedural schedule for the Commission's review and consideration within thirty (30) days of Order No. 22300. 




