Decision and Order No. 22447

DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 21265, filed on September 7, 2004, in the matter of MONARCH LIMOUSINES, LLC, nka SIMPLY EXQUISITE LIMOUSINE SERVICE, LLC ("Respondent").

I.

History

Pursuant to Hawaii Revised Statutes ("HRS") §§ 271-25, 271-36, and Hawaii Administrative Rules ("HAR") §§ 6-62-42(a), § 6-62-24(a), the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on October 6, 2004 to show cause why Respondent's certificate of public convenience and necessity number 1747-C should not be suspended or revoked for failure to file an annual

financial report ("AFR") and pay an annual motor carrier gross revenue fee ("Fee") for the year 2003.

On December 23, 2004, Respondent filed its 2003 AFR, paid its Fee, and paid \$55.30 in penalties and interest that the commission assessed, pursuant to HRS § 271-27(i) and HAR §§ 6-62-24(b)(c) and 6-62-42(d).

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that Order No. 21265, filed on September 7, 2004, should be vacated.

III.


Orders
