Enlargement. (a) When by this chapter or by notice or by order of the commission, any act is required or allowed to be done at or within a specified time, the commission for good cause shown may at any time, in its discretion:

- (1) With or without motion or notice, order the period enlarged, if written request is made before the expiration of the period originally prescribed or as extended by a previous order[.]

HAR § 6-61-23(a)(1).

HECO represents that its timely request for additional time is based on a heavy regulatory workload. HECO specifically cites its on-going work in "Docket No. 05-0315 (HELCO 2006 Test Year Rate Case), 05-0069 (Energy Efficiency proceeding), 05-0145 (HECO CIP Generating Station), 05-0146 (Community Benefits Package), 05-0330 (HECO request for financing), 03-0372 (Competitive Bidding proceeding), 03-0371 (Distributed Generation proceeding) [, and] 2006-0003 (HR Suite System)."³

Based on HECO's representations, the commission approves the request for an extension of time from August 28, 2006 to September 29, 2006, to file the Parties' proposed Stipulated Procedural Order.⁴




THE COMMISSION ORDERS:
