Decision and Order No. **22865**

DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 22740, filed on August 14, 2006, in the matter of VERIZON HAWAII INTERNATIONAL, INC., fka GTE HAWAIIAN TEL INTERNATIONAL INC. ("Respondent").

I.

History

Pursuant to Hawaii Administrative Rules § 6-80-91, Hawaii Revised Statutes § 269-30, and Order No. 20193, the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on September 28, 2006, to show cause why Respondent's certificate of authority should not be suspended or revoked for failure to pay the public utility fee ("Fee") that was due on December 31, 2005, and pay

the telecommunications relay services ("TRS") fund contribution that was due on July 26, 2004.

On September 5, 2006, Respondent paid the Fee that was due on December 31, 2005, and on August 31, 2006, Respondent paid the TRS fund contribution that was due on July 26, 2004.

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable laws, rules, and regulations, and concludes that Order No. 22740, filed on August 14, 2006, should be vacated.

III.

Orders

THE COMMISSION ORDERS:

1. Order No. 22740 is vacated.
2. This Docket is closed unless otherwise ordered by the commission.




