DECISION AND ORDER

By this Decision and Order, the commission vacates Order No. 22756, filed on August 16, 2006, in the matter of INTERNATIONAL TELECOM, LTD. ("Respondent").

I.

History

Pursuant to Hawaii Administrative Rules § 6-80-91 and Order No. 20193, the commission ordered Respondent to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on September 28, 2006, to show cause why Respondent's certificate of authority should not be suspended or revoked for failure to pay the telecommunications relay services ("TRS") fund contribution that was due on July 26, 2003, July 26, 2004, and July 26, 2005.

On September 11, 2006, Solix, Inc. informed the commission that Respondent paid its TRS fund contribution that was due on July 26, 2003, July 26, 2004, and July 26, 2005.

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the commission's applicable laws, rules, and regulations, and concludes that Order No. 22756, filed on August 16, 2006, should be vacated.

III.

THE COMMISSION ORDERS:

1. Order No. 22756 is vacated.
2. This Docket is closed unless otherwise ordered by the commission.
