ORDER

By this Order, the commission orders that Decision and Order No. 22559 is vacated and this docket is closed.

I.

Application for Common Carrier Authority

On April 10, 2006, MALCOLM DUANE MEDEIROS, dba XXX TOWING ("Applicant"), filed an application requesting a certificate of public convenience and necessity ("Certificate") to operate as a common carrier of property by motor vehicle over irregular routes on the island of Hawaii in the general commodities classification. By Decision and Order No. 22559, filed on June 23, 2006, the commission granted Applicant a Certificate subject to certain requirements.

On October 16, 2006, Applicant filed a request to withdraw his application.¹ Applicant decided to maintain his

current business only, which is towing disabled vehicles, as the additional cost of the requisite insurance was prohibitive. In light of this request, the commission finds good cause to vacate Decision and Order No. 22559, and to close this docket.

THE COMMISSION ORDERS that Decision and Order No. 22559 is vacated, and this docket is closed unless otherwise ordered by the commission.


