Request to Surrender Common Carrier Authority

2006, October 30, Petitioner filed On requesting commission approval letter to voluntarily surrender his authority under Certificate No. 1501-C. Under Certificate No. 1501-C, Petitioner is authorized to transport passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification.

Findings and Conclusions

In accordance with Hawaii Revised Statutes ("HRS") § 271-19, operating authority under a certificate of public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate his authority.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Petitioner's authority to transport passengers under Certificate No. 1501-C is terminated, effective from the date of this Order.
- 2. Petitioner shall remove any markings from the vehicles used in his operations. Petitioner shall comply with the foregoing requirement within fifteen (15) days from the date of this Order.
- 3. If Petitioner fails to comply with the foregoing requirement within the time period specified, he may be subject to penalties pursuant to HRS § 271-27.
- 4. This docket is closed unless otherwise ordered by the commission.
