ORDER

By this Order, the commission approves the withdrawal of Rocky Mountain Institute ("RMI") as a participant in the instant proceeding.

I.

Background

By Order No. 22663, filed on August 1, 2006, RMI was granted participation status without intervention, limited to the issues of tiered rate pricing, time of use pricing, energy cost adjustment charge, net energy metering and the renewable energy and energy efficiency program for affordable homes.<sup>1</sup>

By Notice of Withdrawal filed on November 29, 2006 ("Notice of Withdrawal"), RMI informed the commission that it "hereby files its Notice of Withdrawal as a participant from this [d]ocket."<sup>2</sup> Having reviewed the record, the commission finds good cause to approve RMI's withdrawal as a participant in this





RMI's Notice of Withdrawal, filed on November 29, 2006, is approved.


