ORDER

By this Order, the commission terminates certificate of public convenience and necessity no. 4088-C ("Certificate No. 4088-C"), held by LYNDON ROXFORD LANAKILA DELA CRUZ, dba MOLOKAI MOVING & STORAGE ("Petitioner"), effective from the date of this Order.

I.

Request to Surrender Common Carrier Authority

On October 24, 2006, Petitioner filed a letter requesting commission approval to voluntarily surrender his authority under Certificate No. 4088-C. Under Certificate No. 4088-C, Petitioner is authorized to transport property by motor vehicle over irregular routes on the island of Molokai in the household goods classification.

II.

Findings and Conclusions

In accordance with Hawaii Revised Statutes ("HRS") § 271-19, operating authority under a certificate of public convenience and necessity may be terminated upon application of the holder. The commission finds good cause to grant Petitioner's request to terminate his authority.<sup>1</sup>

III.

Orders

THE COMMISSION ORDERS:

1. Petitioner's authority to transport property under Certificate No. 4088-C is terminated, effective from the date of this Order.
2. Petitioner shall remove any markings from the vehicles used in his operations. Petitioner shall comply with the foregoing requirement within fifteen (15) days from the date of this Order.
3. If Petitioner fails to comply with the foregoing requirement within the time period specified, he may be subject to penalties pursuant to HRS § 271-27.

<sup>1</sup>At the same time, we note that Petitioner has not filed his 2006 AFR and applicable fee for the period from January 1, 2006 to October 24, 2006 (the date that Petitioner's request was filed) pursuant to our e-mail request of October 31, 2006, and our letter dated December 6, 2006. Thus, should Petitioner in the future request authority to operate as a motor carrier, he will need to first, if he has not yet done so, satisfy this matter before his application is reviewed by the commission.

4. This docket is closed unless otherwise ordered by the commission.
