DECISION AND ORDER

By this Order, the commission grants MICROPLANET, INC.'s ("MicroPlanet") Motion to Withdraw Petition ("Motion"), filed on January 31, 2007.¹

I.

Background

On November 17, 2006, MicroPlanet filed a Petition for Declaratory Ruling ("Petition") requesting a declaratory order regarding qualification of MicroPlanet's electronic voltage regulation technology as "renewable electrical energy" in accordance with Hawaii Revised Statutes ("HRS") ch. 269, as amended.

By Order No. 23105, filed on December 4, 2006, the commission, among other things, named HAWAIIAN ELECTRIC COMPANY, INC. ("HECO"), HAWAII ELECTRIC LIGHT COMPANY, INC. ("HELCO"),

MAUI ELECTRIC COMPANY, LIMITED ("MECO"), and KAUAI ISLAND UTILITY COOPERATIVE ("KIUC") as parties to this docket.²

On January 31, 2007, MicroPlanet filed the instant Motion, requesting to withdraw its Petition and close the instant docket. None of the Parties filed an opposition to MicroPlanet's Motion.

II.

Discussion

In its Motion, MicroPlanet states that "Petitioner has been in discussions with HECO and HECO has determined that Petitioner's voltage regulation products are eligible for HECO rebates under its Demand Side Management Program as an Energy Solution for Business." Thus, MicroPlanet states that it "believes its Petition is no longer necessary." Based on MicroPlanet's assertions, and the lack of any objection to MicroPlanet's Motion, the commission determines that MicroPlanet's Motion should be granted and this docket closed.

Microplanet, HECO, HELCO, MECO, KIUC and the Consumer Advocate are collectively referred to as the "Parties."

2. This docket is closed unless otherwise ordered by the commission.


