ORDER

By this Order, the commission approves PUKALANI ASSOCIATES, LLC's ("Movant") "Motion to Withdraw Without Prejudice (1) Written Request for Enlargement of Time, Filed September 10, 2007, (2) Motion for Enlargement of Time to File Motion to Intervene; Affidavit of Judy A. Tanaka; Exhibit "A" and Certificate of Service, Filed September 10, 2007, and (3) Motion to Intervene; Exhibits "A" - "C"; Verification; and Certificate of Service, Filed September 10, 2007" ("Motion to Withdraw"), which was filed on September 13, 2007.

I.

Motion to Withdraw

On September 13, 2007, Movant filed its Motion to Withdraw, requesting that the commission withdraw without prejudice its: (1) Written Request for Enlargement of Time, filed

on September 10, 2007; (2) Motion for Enlargement of Time to File Motion to Intervene, filed on September 10, 2007; and (3) Motion to Intervene, filed on September 10, 2007. Movant stated that, based on notification by commission staff that the commission would be publishing notice of the application filed in this docket, the deadline to intervene will be twenty days after publication, and Movant's requests for an enlargement of time to file its Motion to Intervene, are unnecessary. Moreover, Movant explained that it is attempting to resolve issues with PUKALANI STP CO., LTD and HAWAII WATER SERVICE COMPANY, INC., such that a withdrawal of Movant's Motion to Intervene is warranted.

Upon review, the commission finds that Movant's Motion to Withdraw is reasonable, and should be approved.


THE COMMISSION ORDERS:


